New Business

- MLWSSD – Board concerns - Negotiations with the City of ML continue with little progress. City proposes a \$15 flat fee increase to each user starting in January 2025. Currently the MLWSSD is paying about \$80,000 a year to the city. The proposed increase would create an additional \$85,000 a year. When asked what the increase would cover, there was concern over some of the charges such as depreciation which includes the city components as well as depreciation which MLWSSD already pays a separate fee to cover. An additional concern is with the flow monitoring system. Several requests have been made to have the system checked for accuracy. The test would take about 15 minutes and be of no cost. The city has declined for various reasons.
- Snowplow turnaround on Koecher Road – Currently there is not sufficient room for a snowplow to turn around due to items potentially in the right of way. Steve will reach out to the property owner to see if they would be willing to move some items. Otherwise, the less of the road may be available to be plowed

- MAT Insurance & Bond Trust – Annual MATIT Worker's Compensation Audit document shared. Audit is due in February.
