- Fire District - none

- Library – book sale June 17 – 19th will include food truck and vendors. A draft document is with the City Council with regards to appointments to the library.

Old Business

- Disc Golf – Civil Air Patrol Cadets will work on the disc golf course. Permanent baskets will be researched with options presented at the next meeting.

New Business

- Al Cekalla – Current field needs attention. Desire to have 25 ton (1 semi-truck load) of ag lime at a cost of about \$1,600 if delivered. May take about 10 hours of volunteer time to dig out and add product to the field. Motion made by Tracy to purchase the product to be added with volunteer labor, second by Bob. Motion carried.
- Rebels Home Run Club – City of Moose Lake informed the Rebels Home Run Club in December 2024 that the Halvorson field is not being repurposed. The club is able to continue use of the field for Little League games through 2027. The club is no longer able to lead on the endeavor to build a little league field at the Art Ohlgren Park. Options to make the township whole after splitting the cost of design was discussed. A letter will be composed and shared with the club.
- Road Review Findings
 - SCI damage – Donna will contact SCI to discuss damage to culvert on Mills Road
- Request for Dust Control – a request for adding a section of Koecher Road to the dust control treatment was shared. The dead-end road has a limited number of houses and is not a high-volume road. Resident is able to contact Carlton County to request dust control applications.
- Route 61 Liquor License – approved and signed by chair. Donna to deliver to business the next day.
- Men's and women's softball league play at Art Ohlgren Park – reservation approved.
 - Men – Mondays starting on May 12th through August
 - Women's – Wednesdays starting on May 14th through August
 - Portable restrooms start May 1st and will continue through fall.
